All temporary signs shall have the date of removal printed clearly on the lower right hand corner, as viewed from the exterior, and shall be permitted for a period not to exceed ten (10) days in any thirty (30) day period. Temporary banners must be a maximum of twenty (20) square feet. Temporary construction signs, temporary subdivision or condominium development signs and temporary commercial banners require a permit and a \$15.00 fee per Village Council resolution.

Standards for issuance of a temporary special event permit shall include the following:

1. All other temporary sign duration will be permitted per Section 7.07. If no duration is indicated, temporary signs shall be permitted for no more than ten (10) days in any thirty (30) day period.
2. The location of the temporary special event sign shall not interfere with general public health, safety and welfare.
3. The location of the temporary special event sign shall not interfere with vehicular or pedestrian safety and welfare.
4. Applicant has provided a location map and scale drawing of the signs. Banner signs are not to exceed 20 square feet in size.
5. Any deposit requirements shall be determined and paid at the time the permit is approved.
6. Temporary Construction sign permits, per Section 7.07(2), shall not be permitted for a period of more than 6 months.
